Ofsted

Aylward Academy, is delighted to announce that they have just been graded as a "Good" Academy in all categories in their latest Ofsted report. Aylward Academy opened in 2010 and in a short amount of time the Academy has moved up from a school that had a "Notice to Improve", (grade 4) to an Academy that is now "Good" (grade 2). The staff and pupils are extremely proud of this huge improvement and are determined to keep up the hard work to ensure Ofsted, when they return, find the Academy to be an "Outstanding" institution.

In the latest Ofsted inspection the report confirms that, "Students make good progress across a range of subjects" (Ofsted November 2016).

Leadership and Management of the Academy was praised within the report. The Ofsted team found that, "Leaders have focused on ensuring that the curriculum is wide and varied to meet the needs of the diverse pupil population". Also, "Middle leaders share senior leaders' vision for the school".

The Academy continues to see an improvement in results, especially students gaining A and A* at G.C.S.E. and consistently records very high pass rates at 'A' level.

Job Description

Post Title: School Learning Resource Centre Manager

Responsible to: Assistant Vice Principal with responsibility for Literacy

Responsible for: LRC Assistant(s)

Hours: 36 hours per week

Status: 42 weeks per annum

Job Purpose: The Learning Resource Centre Manager/School Librarian

manages and operates a major learning environment used by the whole school community in the LRC and the Academy library, "The Book Loft". The Learning Resource Centre Manager/School Librarian is responsible for the acquisition, organisation, dissemination and exploitation of resources

appropriate to the learning needs of the full age and ability range

within that community

Main Functions:

- Advise senior management and other colleagues on policies for the provision of learning resources across the curriculum including the usage of all spaces. Support the educational aims and objectives of the academy, and monitor the effectiveness of the learning resource centre's contribution to learning and teaching.
- Mediate between learners and resources to enable learners to identify, locate and access the information they need. This will include delivering small group workshops to students to support their literacy skills, especially at KS5.
- Lead the teaching of transferable information, learning and knowledge access skills which are the core skills of independent lifelong learning.
- Manage and promote a wide range of resources in a variety of formats, traditional and electronic, and where appropriate, the equipment to access them.
- Promote the development of reading and literacy skills through the Literacy Interventions Programme for information and recreation and take a lead in creating a whole-academy environment which encourages reading for pleasure.
- To provide/organise a service covering the extended school day plus academy holiday cover where applicable.

- Manage a study environment for both curriculum-based and independent learning. This involves the management and integration of both physical areas and virtual learning environments to create positive learning spaces.
- Enable teaching staff to maintain a high level of awareness of professional development and relevant resources through the provision of appropriate professional materials and information.
- Participate in academy wide improvement through attending the regular cycle of meetings with senior staff.
- Collaborate with feeder primary schools to support transition between KS2 3
- Work with FE institutions to develop information literacy strategies to support 14-19 vocational learning.
- Involve the school library in home-school liaison projects that develop and support family learning and promote local community engagement with the school.
- Support the engagement of parents/carers in their children's learning and curriculum needs.
- Line-manage the learning resource assistants to ensure smooth running of both the LRC and Book Loft provisions.
- Ensure that the library supports all aspects of every student's development through understanding the Every Child Matters outcomes, supporting the pastoral programme within the academy, providing images for self-esteem and developing social skills through participation in library based activities.
- Continue with the oversight and development of the Accelerated Reader Programme
- Oversight of Reading Age Data and implementation of interventions to ensure student reading age continues to progress
- Promotion of the Book Loft and Whole School Literacy through event days, inviting in authors etc
- Continue with the oversight of provision of Lexia to ensure all student literacy levels continue to progress
- Oversight of the Academy "Drop Everything and Read" intervention

Other clauses:

- 1. The above responsibilities are subject to the general duties and responsibilities contained in the Statement of Conditions of Employment.
- 2. This job description allocates duties and responsibilities but does not direct the particular amount of time to be spent on carrying them out and no part of it may be so construed.
- 3. The job description is not necessarily a comprehensive definition of the post. It will be reviewed at least once a year and it may be subject to modification or amendment at any time after consultation with the holder of the post.
- 4. This job description may be varied to meet the changing demands of the academy at the reasonable discretion of the Principal.
- 5. There may be occasions when it will be necessary to cover other Administrative roles within the academy or to work with the administrative team when there are peaks and pressing issues.

The probation period is a trial period, to enable the assessment of an employee's suitability for the job for which they have been employed. It provides the academy/trust with the opportunity to monitor and review the performance of new staff in relation to various areas, but also in terms of their commitment to safe guarding and relationships with pupils.
