£2k relocation if moved for first time into a Stoke school from a school out of Stoke - Form Reloc 2017/18

B NQT in 2016/17

2k if retained in City for 2017/18 - Form NQT 2016/17

Plus a further 2k if retained for 2018/19 - Form RQT 17/18

C NQT in 2017/18

2k if retained for 2018/19 - Form NQT 2017/18

D ITT trainees 2017/18 – the OAKS, St Joseph's SCITT, Staffordshire University PGCE

£2k for a placement in a Stoke School (maximum 2 schools) in 2017/18 - Forms ITT1 & 2

£5k if NQT in City in 2018/19 - Form NQT 2018/19

A Relocation Package for newly appointed mathematics teachers who take up post in the 2017/18 academic year

A relocation package is offered to mathematics teachers who relocate to state-funded Stoke-on-Trent secondary schools during the 2017/18 academic year. This is £2,000.

The wording to be used in any advertisement is as follows:

Successful applicants will become part of an innovative project, which includes support and development opportunities as well as financial incentives; this includes a relocation allowance of £2000. Further financial incentives are available through the Mathematics Excellence Partnership (MEP).

Schools/academies should pay the mathematics teacher the £2,000 with their first payment salary after proof of relocation has been verified and then send the signed relocation form and an invoice to Stoke MEP via St Joseph's College.

We will require proof of relocation in order to credit your school/academy. This should be proof that this is the mathematics teacher's first teaching post in a Stoke-on-Trent secondary school. **Form Reloc 17/18**

N.B Mathematics teachers are defined as those teaching mathematics for at least 75% of their teaching timetable during the academic year in which they are appointed.

B Incentive allowance for Teachers who were NQTs in 2016/17 in Stoke and have been retained in the City

For teachers who have successfully completed their NQT year in 2016/17 and are retained in the City, an incentive allowance of £2k will be paid for retention into 2017/18.

NQTs from 2016/17 who have been retained for a second year are entitled to an NQT incentive as above. This can be claimed for the 2016/17 year up to December 31st 2017.

In September of the second year (2017) this should be paid to the teacher by the school and an invoice should be send to St Joseph's College reference Stoke MEP together with **Form NQT 16/17**

If the teacher is retained in the City for 2018/19 a further £2k can be claimed in September of the third year (2019) FORM RQT 2017/18

C Incentive allowance for NQT mathematics teachers in 2017/18

Mathematics NQTs who begin their teaching career in a state-funded Stoke-on-Trent secondary school in 2017/18 will receive an incentive allowance of £2000 at the end of their first year if retained for a second year in the City.

In October of the second year (2018) this should be paid to the teacher by the school and an invoice should be send to St Joseph's College reference Stoke MEP together with **Form NQT 17/18**

N.B Mathematics teachers are defined as those teaching mathematics for at least 75% of their teaching timetable during the academic year in which they are appointed.

D Stoke MEP bursary for OAKS SCITT, St Joseph's College SCITT and Staffordshire University

Graduate trainees training to teach with the above providers may be entitled to a relocation allowance and a Stoke MEP bursary.

A bursary of £2k will be made to a trainee via the provider if the trainee has their first placement in a Stoke on Trent Secondary school. The trainee should complete form **ITT 1** and payment should be made by the provider in November 2017 with an invoice sent to Stoke MEP, c/o St Joseph's College

A bursary of £2k will be made to a trainee via the provider if the trainee has their second placement in a Stoke on Trent Secondary school. The trainee should complete form **ITT 2** and payment should be made by the provider in February 2017 with an invoice sent to Stoke MEP, c/o St Joseph's College

An additional bursary of £5k will be made to a teacher training to teach with the providers above in 2017/18 if they secure an NQT position in a school in Stoke for 2018/19. This can be claimed after commencement of the post – in October 2018. The NQT should complete form **NQT 18 /19** and payment should be made by the school in October 2018 with an invoice sent to Stoke MEP, c/o St Joseph's College
