6.	A good, up to date working knowledge and understanding of teaching, learning and behaviour management strategies.
7.	Good written communication skills
8.	Evidence of relevant and on-going professional development and training, (not applicable for a NQT.)

Desirable

9.	Experience of teaching A Level.
10.	Other interests / expertise that would benefit learners and the school.
11.	Knowledge of examination / testing requirements.
12.	Able to teach in an additional subject area
