- To ensure class rooms are set up ready for teaching with teaching materials out and ready to be used
- To support staff in lesson preparations including photo-copying and formatting booklets/materials
- To be pro-active in receiving set-up orders from staff to ensure lessons and transitions are smooth
- To deliver outstanding support to teachers delivering practical subjects
- To keep abreast of developments in Health and Safety, especially in Food & Nutrition
- To support enrichment opportunities and support students within Food & Nutrition, Art, Textiles, including the enrichment class programme, G&T sessions, trips etc.
- To be flexible and prioritise tasks across the department and the across the three subjects
- To undertake duties as directed and in accordance with Academy expectations
- To support with Academy productions and other events
