<b>Main Duties</b>	<ul style="list-style-type: none"> <li>▪ To ensure that the work set for the students during a cover lesson is completed;</li> <li>▪ To ensure students are informed of any homework requirements during a cover lesson;</li> <li>▪ To monitor and control the use and storage of teaching materials, books and equipment during cover lessons;</li> <li>▪ To supervise students whilst they are studying independently and ensure that they study purposefully;</li> <li>▪ To supervise students during tutorial and assembly time;</li> <li>▪ To assist in the educational and social development of the students under the direction and guidance of the Line Manager and subject teachers;</li> <li>▪ To plan learning activities and assist with the development of learning materials under the direction of the Line Manager and subject teachers;</li> <li>▪ To provide learning support for individual students inside and outside the classroom;</li> <li>▪ To liaise with other professionals, for example the Senior Leadership Team Student Development Leaders and the SENCO to ensure that the needs of all students are met;</li> <li>▪ To ensure, if required, that the school library is kept in good order and that the students use the library responsibly;</li> <li>▪ To supervise the use and care of the school fabric and equipment by the students and to ensure their adherence to relevant health and safety regulations;</li> <li>▪ To assist subject teachers with maintaining student records;</li> <li>▪ To run lunchtime activities as required</li> <li>▪ To liaise with parents as required.</li> </ul>

<b>Administrative Duties</b>	<ul style="list-style-type: none"> <li>▪ To use the lesson monitor registration system and other SIMs applications according to school procedures;</li> <li>▪ To prepare and present displays of students' work;</li> <li>▪ To carry out basic technician duties including the setting up of equipment as and when required for lessons;</li> <li>▪ To support subject teachers in photocopying and other tasks in order to support teaching;</li> <li>▪ To prepare materials and support learning needs of individual students as required.</li> <li>▪ To attend meetings as necessary;</li> <li>▪ To input data as necessary;</li> </ul>
<b>Additional Duties:</b>	<ul style="list-style-type: none"> <li>▪ To undertake training as necessary;</li> <li>▪ To follow procedures with regard to evacuation and emergency procedures;</li> <li>▪ To take reasonable care of his/her own health and safety and that of others who may be affected;</li> <li>▪ To engage actively in the performance management review process and to undertake reviews as required;</li> <li>▪ To continue personal development as agreed at your PMR;</li> <li>▪ To address the appraisal targets set by the Line Manager;</li> <li>▪ To carry out duties as outlined in the targets set each year;</li> <li>▪ To undertake any reasonable tasks as designated by the Line Manager or SLT;</li> <li>▪ To play a full part in the life of the School community, to support its distinctive aim and ethos and to encourage staff and students to follow this example;</li> <li>▪ To adhere to the School's policies;</li> <li>▪ To promote actively the School's corporate policies;</li> <li>▪ To inform the Estate Manager of any matter that would reasonably be considered to represent shortcoming in the arrangements for health and safety.</li> <li>▪ To show a record of excellent attendance and punctuality.</li> </ul>
