Pastoral System:	<ul> <li>To be a Form Tutor to an assigned group of students.</li> <li>To promote the general progress and well-being of individual students and of the Form Tutor group as a whole.</li> <li>To liaise with a Pastoral Leader to ensure the implementation of the school's Pastoral System.</li> <li>To register students, accompany them to assemblies; facilitate and lead collective worship in tutor groups and year assemblies; encourage their full attendance at all lessons and their participation in other aspects of school life.</li> <li>To evaluate and monitor the progress of students and keep up-to-date student records as may be required.</li> <li>To contribute to the preparation of Action Plans and progress files and other reports.</li> <li>To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved.</li> <li>To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff</li> <li>To contribute to PSHE and citizenship and enterprise according to school policy</li> <li>To apply the Behaviour management systems so that effective learning can take place.</li> </ul>
