#### 1.2 MAIN PURPOSE OF JOB

As a main scale teacher you are expected to plan and deliver high quality lessons and learning experiences which meet not only the requirements of the National Curriculum but also use its flexibility to engage, motivate and challenge each pupil under your care.

#### 1.3 POSITION IN ORGANISATION

#### **Teaching and Learning**

- To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Department.
- To contribute to the Department Development Plan and its implementation.
- To plan and prepare high quality lessons.
- To contribute to the whole school's planning activities.
- To contribute to the process of monitoring and evaluation of the Department in line with agreed school procedures, including evaluation against quality standards and performance criteria. To seek/implement modification and improvement where required.
- To review from time to time methods of teaching and programmes of work.
- To take part, as may be required, in the review, development and management of activities relating to the Curriculum, organisation and pastoral functions of the school.
- To contribute to the development of effective subject links with external agencies.
- To be a Form Tutor to an assigned group of pupils.
- To teach pupils, according to their educational needs, including the setting and marking of work to be carried out by the pupil in school and elsewhere.
- To assess, record and report on the attendance, progress, development and attainment of pupils and to keep such records as are required.
- To commit to the running of extra curricular clubs.
- To seek additional OSHL opportunities for pupils in the wider community through trips and visits.

#### **Pupil outcomes**

• To maintain appropriate records and to provide relevant, accurate and up to date information for SIMS, registers etc.

- To complete the relevant documentation to assist in the tracking of pupils.
- To track pupil progress and use information to inform teaching and learning.
