Responsible to: The Head Teacher

General Duties

To act within, the statutory frameworks, which set out the professional duties and responsibilities and in line with the duties outlined in the current School Teachers Pay and Conditions Document and Teacher Standards (2012). To take responsibility for promoting and safeguarding the welfare of children and young pupils with dignity, building relationships rooted in mutual respect, and at all times observing proper boundaries appropriate to a teacher's professional position. To provide excellent opportunities for the development of pupils and to establish and maintain positive relations with pupils, parents and the wider school community.

Purpose of job

- To maintain the school's Christian ethos and demonstrate the core values of the school
- To be an effective and reflective classroom teacher able to demonstrate and share good practice.
- To plan and prepare lessons, ensuring that planning, preparation, assessment and reporting meets the individual needs of our children
- Be responsible and accountable for achieving the highest possible standards in work and conduct
- To implement school policies, national requirements and local policies
- To lead by example and to monitor and evaluate classroom practice

Main Duties and Responsibilities

- To undertake the duties and responsibilities of a classroom teacher as set out in School Teachers' Pay and Conditions
- To use assessment data to plan lessons based on a thorough understanding of what the children can do and to use a range of assessment practice to assess pupils' progress and attainment within lessons
- To plan and deliver interesting, stimulating well-structured lessons that motivate and include all learners
- To develop a stimulating and interactive learning environment through the use of display and resources, to engage and inspire
- To ensure the maintenance of good order and discipline among all students and safeguard their Health and Safety, both on school premises and when they are engaged in authorised activities elsewhere.
- To report to parents formally at key points throughout the year and informally through daily discussions

- To work with Senior Leaders and outside agencies to meet the needs of all children
- To keep abreast of current good practice through reading, attending courses, evaluating materials, resources and ideas and visiting schools.
- To establish a partnership with parents involving them in their child's learning through regular communication, after school clubs, workshops and homework etc.
- Work proactively and effectively in collaboration and partnership with learners, parents/carers, governors, other staff and external agencies in the best interests of pupils
- To be able to work effectively and co-operatively within a multi-disciplinary team and to take an active role in school
- To be aware of the school's and the Local Education Authority's Equal Opportunity Policy, ensuring that all children have full access in order to maximise their achievement and minimise inequality.

English

- To provide professional leadership and direction for the teaching of English across the school
- To work with Senior Leadership Team and the inclusion team, ensuring that the needs of all children are met.
- To lead, by example, to develop and enhance the teaching practice of other staff, improving the quality of education and raising standards
- To co-ordinate assessment and record keeping procedures across the school; to analyse data and set clear targets, holding teachers to account
- To prepare for and lead staff meetings
- To prepare displays, assemblies, organise and lead parents meetings as appropriate to promote understanding and development of own area.
- To keep abreast of current good practice through reading, attending courses, evaluating materials, resources and ideas and visiting schools.
- To manage a budget effectively and efficiently ensuring that financial regulations are adhered to.
- To report to the governing body on pupil progress in English

This job description may be amended at any time after discussion with you but in any case it will be reviewed one year after appointment.

- Teachers are responsible to the Headteacher and, in her absence or on her behalf, the Deputy Head Teacher.
- Teachers are accountable to parents/carers and are in loco parentis when engaged in authorised school activities.
- Teachers are responsible for the curriculum they provide which should reflect school and local education policy and Government legislation.
