Role Description:

Responsibilities:

General

- 7. Participate fully in House activities
- 8. Participate in Visits and Expeditions as required

Curriculum

- 1. Possess a functional familiarity with the relationship between the Examination Boards guidelines, Haileybury Astana Units of Work, lesson plans and evaluation for the particular year groups/subjects taught.
- 2. Be familiar with the content, teaching and assessment of IGCSE and IB Business Studies.
- 3. Keep up to date with curriculum developments through reading and CPD opportunities.
