Position Summary: Music is an integral part of Shrewsbury International School's identity and reputation. A large team of academic music staff provide curricular music lessons to all year groups. The department also has a very large and prestigious extra-curricular music programme. There is a plethora of ensembles including a full-sized orchestra, eight choirs, three string orchestras, big band, wind band, as well as numerous smaller informal groups. The department hosts prestige events such as the annual 'Last Night of the Proms', and has innovative and ambitious choir school and class band programmes woven into its curriculum. There is also a very large and well-established tuition programme, with over 1000 instrumental/vocal lessons each week delivered by 30 highly skilled professional

- be a highly accomplished musician on their main instrument or voice; (piano skills would be an advantage)

Key Responsibilities: The Graduate Intern (Music) reports directly to the Director of Music and is primarily responsible for supporting curricular music lessons and organising and preparing for department events. In particular, the Graduate Intern (Music) will be expected to;

- help organise the department's weekly recital programme;
- participate in the school's main ensembles as performer and instructor;
- manage and maintain music resources, including ensemble libraries and musical equipment stocks;
- encourage, and assist informal music-making in the

department;

- support music teachers in the delivery of curriculum music lessons across all year groups;
- if suitably skilled, accompany in rehearsals, concerts and exams;
- oversee key elements of the department's media profile and communications;
- play an active part in all music events;
- teach individual instrumental/vocal lessons;
- be occasionally required to work outside normal hours at the request of the Director of Music with reasonable notice.
