<u>Primary Objective:</u> Coordinate and provide pedagogical leadership, information and support to a range of early childhood education, family and parenting support programs in remote communities across the region.

Context Statement: The Early Childhood Educator supports early learning, preschool and parenting programs for children and their families who live in isolated and remote locations. The Early Childhood Educator works with local Indigenous staff, school principals and community to develop and deliver a range of Early Childhood programs. The programs will work across agencies to promote optimal child development, family engagement which is respectful of Indigenous culture. This position requires extensive remote travel by road to support the establishment and ongoing quality improvement of Early Childhood programs in small Indigenous communities in the Central and Barkly region.

Key Duties and Responsibilities:

- 1. Develop and deliver innovative and appropriate early learning and family support programs in consultation with community agencies which meet the needs of remote families and enhance school readiness.
- 2. Establish and maintain close working relationships with schools and networks with heads of agencies within the community.
- 3. Undertake an appropriate teaching role as identified by Early Childhood Coordinator and provide Pedagogical Leadership for targeted Preschools in small remote sites.
- 4. Provide onsite support for staff working within all early childhood programs.
- 5. Coordinate specific programs and events as required; with a focus on early literacy and numeracy to support successful transition to preschool / school for families and children.
- 6. Work toward the implementation of the National Quality Framework in all Early Childhood Programs
- 7. Provide administrative, performance, and resource reporting for the Early Childhood Coordinator according to departmental and government business systems, policies and processes.

Selection Criteria

Essential:

- 1. Registration with the Teacher Registration Board of the Northern Territory, a current Working with Children Clearance Notice and a current NT Driver's Licence.
- 2. Early Childhood qualification and/or 'demonstrated relevant experience in early childhood education' and ability to deliver high quality early childhood programs.
- 3. Broad knowledge of the National Quality Framework including Early Years Learning Framework (EYLF), and the capacity to develop and implement an effective readiness and transition to preschool / school programs which clearly cater for families and children.
- 4. An ability to interact effectively with people from diverse cultures and other agencies to develop critical relationships for the successful implementation of programs.
- 5. Certificate IV in Training and Assessment and 4WD training or the commitment to obtain.
