Teaching:	 To teach, students according to their educational needs, including the setting and marking of work to be carried out by the student in school and elsewhere. To ensure the additional educations needs of all students are catered for. To assess record and report on the attendance, progress, development and attainment of students and to keep such records as are required. To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students. To ensure that ICT, Literacy, Numeracy and school subject specialism(s) are reflected in the teaching/learning experience of students To undertake a designated programme of teaching. To ensure a high quality learning experience for students this meets internal and external quality standards. To prepare and update subject materials. To use a variety of delivery methods, which will stimulate learning appropriate to student needs and demands of the syllabus. To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework. To undertake assessment of students as requested by external examination bodies, departmental and school procedures. To mark, grade and give written/verbal and diagnostic feedback as required.
Student Support System (Pastoral)	 To be a Form Tutor to an assigned group of students. To promote the general progress and well-being of individual students and of the Form Tutor Group as a whole.



Operational/ Strategic Planning	 To liaise with the Student Support Team to ensure the implementation of Student Support systems. To register students, remain with students in assemblies, encourage their full attendance at all lessons and their participation in other aspects of School life. To contribute to and deliver the School's tutorial programme. To evaluate and monitor the progress of students and keep up-to-date student records as may be required. To contribute to the preparation of Action Plans and progress files and other reports. To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved. To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff To contribute to PSHCE, enterprise education and SMSC according to School policy To apply the Behaviour Management Systems so that effective learning can take place. To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Curriculum Area and Department. To seek/implement modification and improvement where required. To review from time to time methods of teaching and programmes of work. To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions of the school.
Management Information:	 To maintain appropriate records and to provide relevant accurate and up-to-date information for MIS, registers, etc. To complete the relevant documentation to assist in the tracking of students. To track student progress and use information to inform teaching and learning.
Communications:	 To communicate effectively with the parents of students as appropriate. Where appropriate, to communicate and co-operate with persons or bodies outside the school.



Marketing and Liaison:	 To take part in marketing and liaison activities such as Open Evenings Parents' Evenings, Review days and liaison events with partner schools. To contribute to the development of effective subject links with external agencies.
Management of Resources:	 To contribute to the process of the ordering and allocation of equipment and materials. To assist the Director of Learning and Standards to identify resource needs and to
