Key tasks

- To teach in line with the national standards and departmental expectations
- To monitor student learning and ensure appropriate differentiation, thereby maximising student achievement
- To deliver extra-curricular activities
- To develop, to a high standard, your teaching environment to stimulate and support learning
- To develop your professional subject knowledge and expertise, as well as an understanding of education generally
- To be a form tutor
- To attend parents' evenings, meetings and other events as required.

As a teacher

- To follow and develop schemes of work and ensure the delivery of public examination specifications to all students
- To produce lesson plans for all teaching in line with the relevant scheme of work
- To set tasks which challenge students and ensure high levels of interest
- To identify SEN or very able students
- To ensure students acquire and consolidate knowledge, skills and understanding appropriately
- To develop teaching resources for the classroom
- To partake in the development of departmental planning
- To plan and undertake student trips and visits to support the delivery of your subject
- To record and monitor student progress for the purpose of assessment

- To mark students' work carefully and regularly with constructive comments designed to correct misunderstanding and to consolidate learning where appropriate, in line with the school's marking policy
- To write reports as may be required
- To provide homework to support your teaching and to raise achievement
- To set and expect high standards of student behaviour and to have in place strategies to deal with behaviour issues within the classroom
- To ensure that student attendance is accurately recorded during lessons
- If the need arises, to contact parents to discuss attainment or any other issues as necessary
- To develop and lead enrichment activities as part of the school's programme of extracurricular activities
- To evaluate own teaching critically to improve effectiveness
- To cover for absent colleagues within the 'rarely cover' parameters within which we work.

As a tutor

- To use tutor time effectively and deliver tutorial lessons
- To encourage and monitor attendance
- To monitor students' attainment
- To contact parents about, and follow up, absence, behaviour or other issues

As a member of staff

- To teach at other establishments as directed
- To undertake duties in and around the school
- To communicate with parents and other interested agencies as necessary
- To understand, follow and implement school policies
- To give due consideration to coverage of all aspects of student welfare and have regard for the safeguarding and promotion of the welfare of children
- To work at all times towards the Teachers' Professional Standards
