To share and support the Academy's responsibility to provide and monitor opportunities for personal and academic growth. To support the development of the English and Media team. Previous experience teaching Media is desirable. Operational/ Strategic Planning	 To assist in the development of appropriate syllabuses, resources, schemes of learning, marking policies and teaching strategies in the English curriculum area. To contribute to the Curriculum Area and department's development plan and its implementation. To plan and prepare courses and lessons. To contribute to the whole Academy's planning activities. 	
Curriculum Provision:	To assist the Director of English and SLT, to ensure that the curriculum area provides a range of teaching which complements the Academy's strategic objectives.	
Curriculum Development:	To assist in the process of curriculum development and change so as to ensure the continued relevance to the needs of students, examining and awarding bodies pertaining to both GCSE and A-Levels and the Academy's Mission and Strategic Objective.	
Teaching:	 To teach students according to their educational needs, including the setting and marking of work. To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as are required. To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students. To ensure that ICT, Literacy, Numeracy and Academy subject specialism(s) are reflected in the teaching/learning experience of students. To undertake a designated programme of teaching. To ensure a high quality learning experience for students which meets internal and external quality standards. To prepare and update subject materials. To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus. To maintain discipline in accordance with the Academy's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework. To undertake assessment of students as requested by external examination bodies, departmental and Academy procedures. To mark, grade and give written/verbal and diagnostic feedback as required. 	
Staff Development:	 To take part in the Academy's staff development programme by participating in arrangements for further training and professional development and by taking an active role in CPD Sessions. To continue personal development in the relevant areas including subject knowledge and teaching methods. 	
Quality Assurance:	 To help to implement Academy quality procedures and to adhere to those. To contribute to the process of monitoring and evaluation of the curriculum area/department in line with agreed Academy 	

Management Information:	 procedures, including evaluation against quality standards and performance criteria. To seek/implement modification and improvement where required. To review from time to time methods of teaching and programmes of work. To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions of the Academy. To maintain appropriate records and to provide relevant accurate and up-to-date information for MIS, registers, etc. To complete the relevant documentation to assist in the tracking of students. To track student progress and use information to inform teaching and learning.
Communications:	 To communicate effectively with the parents of students as appropriate. Where appropriate, to communicate and cooperate with persons or bodies outside the Academy. To follow agreed policies for communications in the Academy.
Marketing and Liaison:	 To take part in marketing and liaison activities such as Open Evenings Parents Evenings, Review days and liaison events with partner schools. To contribute to the development of effective subject links with external agencies.
Management of Resources:	 To contribute to the process of the ordering and allocation of equipment and materials. To assist the Director of English to identify resource needs and to contribute to the efficient/effective use of physical resources. To cooperate with other staff to ensure a sharing and effective usage of resources to the benefit of the Academy, department and the students.
Pastoral System:	 To be a Tutor to an assigned group of students. To promote the general progress and well-being of individual students and of the Tutor Group as a whole. To liaise with the YPL and Vice Principal to ensure the implementation of the Academy's Pastoral System. To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of Academy life. To evaluate and monitor the progress of students and keep up-to-date student records as may be required. To contribute to the preparation of Action/Improvement Plans and progress files and other reports. To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved. To communicate as appropriate, with the parents of students and with persons or bodies outside the Academy concerned with the welfare of individual students, after consultation with the appropriate staff To contribute to PSHE and citizenship and enterprise according to Academy policy To apply the behaviour management systems so that effective learning can take place.

Other Specific Duties:

To positively engage in the appraisal process and in your own professional development including induction and in-service training opportunities and appraisal. To attend and participate in staff and departmental meetings as appropriate. To make your own contribution to the community life of the Academy.
