



Content Creation & Curation Champion

All MVA staff are expected to embody the Ways of Being in their work with us, to be mindful of their safeguarding responsibility for all students, and to ensure they are familiar with and confident in the implementation of school policies.

In addition to duties associated with other roles they hold, Content Creation & Curation Champions have responsibilities that include to:

New Course Content

- Ensure that any and all course content for which they are responsible is created and maintained in line with MVA VLP guidelines, including and especially those relating to accessibility and differentiation.
- Ensure that all module content and assignments are uploaded to the VLP, checked for accuracy and correct functionality, by the published deadlines.
- Create & curate learning content pages that provide appropriate scaffolding and support for all students, present information in a variety of ways (text, images, videos where appropriate), are engagingly and creatively presented, and provide avenues for further exploration and extension.
- Create & curate quiz pages that provide opportunities for students to test themselves on core/key concepts during their self-study, and that assist in the learning process (e.g. through pre-programmed feedback - for correct answers, to stretch students' thinking; for incorrect answers, to guide them towards success in their next attempt).
- Create & curate key assignments, appropriately differentiated and scaffolded and, where possible, incorporating varied ways in which students can complete their work, allowing for different approaches to applying and demonstrating their learning.

- Liaise with Subject Leaders to ensure that subject-specific and school-wide priorities and initiatives are reflected in VLP courses.
- Ensure that assignment due dates are accurate for each set of students within courses.
- Create, maintain & add to general course and subject resources, including syllabus and course information, carefully-selected and clearly-organised revision areas, as well as work experience and careers resources (in consultation with the Subject Leader).
- If asked, work with the MVA Studio team to provide scripts for high-quality educational videos to enhance VLP courses.
- Effect the addition of MVA Studio video resources into individual modules and revision areas in VLP courses.
- Attend training sessions relating to VLP course and participate actively in opportunities for sharing best practice across the CCCC team
- Maintain efficient and timely communication with Subject Leaders, colleagues and others via email, Canvas Inbox and, internally, Google Chat.
