We have a relentless focus on raising the academic progress of our students. Teaching and Learning is a passion of all our staff and we believe it is the key to school improvement. When every teacher is delivering outstanding learning day in day out, when every teacher truly loves their subject, has a sense of humour and makes learning fun and when every teacher knows the detail and nuances of the exam specifications to deliver top notch results then, genuine sustainable school improvement will take place. We are passionate about ensuring every classroom is filled with this type of teacher.

On top of the classroom teaching from our excellent staff we have extended the school day until 4pm for our Y11 students in core subjects, we provide 1 to 1 tuition and run intensive academic residentials to accelerate learning. Also to raise academic standards and student aspiration we are working with professional coaches who are renowned for improving achievement and standards in schools nationally; these coaches have also had success working with multinational companies including NIKE and Chelsea football club. Our students recently commented to OFSTED on the positive impact these interventions were having. OFSTED also commented very positively on the academic improvement taking place across all year groups in the Academy in the recent visit.

We are also very passionate about our competition based house system. The aim is to build teamwork, confidence and community through competition. There are four houses: Johnson, Wilberforce, Sullivan and Reckitt. Every student is a member of one of the houses and competes to earn points for their house. Students can earn points for things such as attendance, progress, photography, sport, poetry, chess etc. You name it, we've got a competition to enable everyone to get involved. We want every student to develop the character, grit and determination to enable them to compete and experience what it feels like to be part of a successful team as well as getting first hand experiences of team camaraderie and team spirit.

At Kingswood Academy we have a multi-million-pound building which was named as one of the best buildings in the UK by the country's most prestigious architectural institution the Royal Institute of British Architects (RIBA). The state of the art facilities provide students with a superb learning environment in which they can excel. Every classroom at Kingswood Academy is spacious, bright and modern, equipped with the latest technology to support learning. Our other facilities include a professional theatre and recording studio, a full size 4G football pitch, a range of dance and drama studios, a state of the art design and technology workshop.

Our academic performance

This summer (2017), for the third year running, we celebrated our best ever GCSE results. We, yet again, had significant increases in the number of students achieving a grade 4 (old C grade pass) in both English and Maths. Our progress scores were excellent and again significantly improved. Our Progress 8 score of +0.46 puts us in the top two schools in the city and shows that on average all our students made almost half a grade more than expected nationally across every one of their 8 subjects from their starting points. 66% of our students are disadvantaged, our Progress 8 score for disadvantaged students was +0.52. At Kingswood Academy all students make good progress in every subject, regardless of their starting point.

Ofsted

We are a rapidly improving school (currently judged to be 'requires improvement') with a positive monitoring inspection in June 2017, which followed our full inspection in March 2016. Prior to this we were deemed to be an academy in serious weaknesses. Through the rapid improvement of outcomes over the last two years, the aim is to achieve 'Outstanding' within 12 months. Job Description

Job title: Teacher of Geography

Accountable to: Leader of Geography

Purpose of Post:

Details of key responsibilities for the Teacher of Geography:

- **Live and breathe our vision and key drivers**
- Delivery of a consistently high quality of teaching, learning, assessment and high standards of achievement;
- Meeting the Kingswood Academy Teaching and Learning Standard and the Kingswood Standard of Marking. Also addressing any underperformance where the standards are not met;
- Evaluating student target and performance data for their teaching as required, and ensure it is analysed as set out in the academy calendar or other such documents;
- Positively engage and partake in all activities and events on the Kingswood Academy Assessment Calendar;
- Demonstrating positive approaches in matters relating to student discipline and contact with parents and so forth;
- Assist in producing and updating programmes of study and schemes of work including suitable assessments for each learning cycle for the Geography department;
- Ensuring that there is an atmosphere conducive to quality learning within the curriculum area, and that students' experiences are challenging, stimulating and differentiated according to need;
- To ensure provision for different groups of students within the subject, including SEND, higher ability, disadvantaged, etc.;
- Ensure that all lessons taught conform to good practice as identified in the academy wide or department development plan.
- To be an active member of the Faculty through involvement in course development, consultation and planning on whole academy issues;
- To undertake other tasks as appropriate and consistent with the Teachers' Pay and Conditions of service;
- All staff who are appointed to the academy are expected to teach across the age and ability range
- All teachers are expected to act as an Academic Mentor in accordance with the academy requirements.

- All staff are expected to develop the academy's commitment to the principle of equal value and work to achieve the aims of the academy mission statement.
- All staff are expected to participate in opportunities for collective decision making including staff appointment and policy making;
- All staff are expected to take a whole academy perspective in monitoring student behaviour outside the classroom paying particular attention to care and respect of the environment, adherence to expectations, uniform and time keeping;
- Such other duties as may be required by the Principal.

Academic Mentors are expected to:

- Mark and maintain registers of attendance;
- Deliver the Academic Mentoring programme through Academic mentoring (30 mins per day);
- Monitor the academic progress of students, guiding and advising them on areas for improvement;
- Maintain and monitor records on students' behaviour, following up on incidents in lessons while also recognising and rewarding students' achievements;
- Monitor students' uniform and ensuring they are equipped for lessons;
- Link with parents to help students' to improve their attendance, punctuality, behaviour and academic progress.
- Teach elements of the PSHE scheme of work;

Impact on educational progress beyond assigned pupils

- Monitor and evaluate assessment data across their classes to evaluate trends in student performance and issues for development;
- Implement intervention strategies to address issues for development that are identified;
- Evaluate and report on the effectiveness of intervention strategies used to address identified issues;
- Identify quantifiable and challenging pupil progress target levels and objectives;
- Planning appropriate strategies to achieve pupil progress targets and objectives;
- Ensure that agreed student progress target levels within the department are achieved or exceeded;
- Encourage students' motivation and enthusiasm, developing positive responses to challenge and high expectations;
- Monitor the objectives and targets for students with SEN and promote the importance of raising their achievement.

In addition to the above requirements, all Academy teachers are required to:
