- To contribute to cross curricular activities.
- To keep records of teaching and of individual pupils' progress and development
- To work with other staff, to co-ordinate schemes of work and to give and receive assessment data for pupils moving up the school.
- To attend staff meetings as required.
- To prepare reports and attend parents' evenings. To liaise with parents (in consultation with the Executive Head) regarding pupil learning issues in English.
- To promote Equal Opportunities and support school policies.
- To keep up to date with school and Cognita policies and initiatives.
- To carry out any additional responsibility negotiated with the Executive Head.
