To provide necessary data and to use data effectively to identify learners needs and those who are underachieving within your responsibility, and where necessary, create and implement effective plans of action to support them.</li> <li>7. To analyse and interpret all appropriate evidence both in school and from outside to inform, policies, practices, expectations, targets and teaching methods.</li> <li>8. To evaluate your teaching and use this analysis to identify effective practice for implementing a variety of teaching strategies and areas for your own professional improvement.</li> <li>4. Plan appropriately to meet the needs of all pupils through differentiation tasks</li> <li>5. To maintain discipline in accordance with the school procedures and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.</li> <li>6. To establish and implement school policies and practices for assessing, recording and reporting on learners’ achievement and for using this information to recognise progress in report writing and record keeping.</li> <li>7. To ensure that information about learners’ achievements in previous classes is used for valued further progress.</li> <li>8. To set expectations and clear targets for support staff and learners, based on prior attainment, in relation to the standards and needs of the learners’ and evaluate progress, achievement and the next steps for further progress to be made.</li> <li>9. Maintain good order and discipline amongst pupils, in accordance with the school's behaviour policy as part of the school duty of care, pastoral and welfare support.</li> <li>4. To be familiar with the Fire Drill and evacuation procedures and school medical routines and responsibilities.</li> <li>5. To report all accidents of children to senior staff and after consultation to parents when appropriate.</li> <li>6. To accompany a staff member and injured child, who requires urgent medical attention (if necessary).</li> <li>7. To support the school in meeting its legal requirements for worship.</li> <li>8. To liaise and maintain good relationships with parents, relatives, guardians</li> </ol>

To take part in the school routines for Performance Management and Continuing Professional Development and to be responsible for your own Professional Portfolio, in line with the Policies and Code of Practice for the School with regard to Performance Management, Career pathways, Recruitment and retention of staff, Staff Discipline and Pay.
