MAIN PURPOSE

To carry out the professional duties of a teacher in line with the current Professional Standards Framework for Teachers and any subsequent amendments.

To teach pupils in the age range 3-11 years.

To teach all subjects in the Mylnhurst curriculum according to agreed curriculum policies and schemes of work, in a manner that is appropriate to the age, stage of development and experience of the children and that takes into account their differing learning styles.

To plan, monitor, review and evaluate programmes of work and other professional activities on a regular basis in order to enhance the quality of teaching and learning, in conjunction with teachers within your Key Stage or the whole staff, as appropriate.

To encourage independent, autonomous learners who are actively involved in their learning and progress.

To assess, record and report children's progress according to the school's assessment and reporting policies.

To use formative assessment information to personalise the curriculum ensuring good progress for all children.

To create an exciting, stimulating, well-organised learning environment, both in and out of the classroom, that is child-centred, attractively presented and that supports and promotes children's learning in a positive way.

To develop a growth-mindset in yourself and the pupils in your care.

To have high expectations of the children in all aspects of their school life so that they are encouraged to achieve excellence in their work, to develop a strong sense of responsibility for themselves and their actions and to respect other people and their experiences, property and the environment.

To ensure that equal opportunities principles play an explicit, as well as implicit role in the classroom.

To organise equipment and resources for the classroom that support and develop the curriculum.

To develop professionally according to your personal needs, the needs of your classroom and the curriculum.
