Job Purpose: Teaching	<p>Set high expectations, which inspire, motivate and challenge pupils by:</p> <ul style="list-style-type: none"> • Establishing a safe and stimulating environment for pupils, rooted in mutual respect • Setting goals that stretch and challenge pupils of all backgrounds, abilities and dispositions • Demonstrating consistently the positive attitudes, values and behaviour, which are expected of pupils. • Promoting good progress and outcomes for pupils by: <ul style="list-style-type: none"> • Being accountable for pupils' attainment, progress and outcomes • Planning teaching to build on pupils' capabilities and prior knowledge • Guiding pupils to reflect on the progress they have made and their emerging needs • Demonstrating knowledge and understanding of how pupils learn and how this impacts on learning • Encouraging pupils to take a responsible and conscientious attitude to their own work and study. <p>Demonstrate good subject knowledge by:</p> <ul style="list-style-type: none"> • Having a secure knowledge of the relevant subject(s) and curriculum areas, foster and maintain pupils' interest in the subject, and address misconceptions • Demonstrating a critical understanding of developments in the subject and curriculum areas, and promote the value of scholarship • Demonstrating an understanding of and take responsibility for promoting high standards of Literacy, articulacy and the correct use of standard English <p>Plan and teach well-structured lessons by:</p>
