Valence School Job description: EARLY YEARS TEACHER

Responsible to: Vice Principal – Teaching and Learning

Main purpose

To prepare students for assessment to national standards and teach and assess pupils across the whole ability range, planning individual programmes of work. To plan, develop and deliver the Primary Curriculum as required by the school to ensure appropriate progress of students. And work flexibly and creatively to deliver lessons to students and groups from Key Stage 1 and 2 as part of wider Lower School teaching.

Duties and responsibilities

- To co-ordinate, plan and teach the Primary curriculum for the school, in consultation with the Assistant Head of Lower School.
- To maintain appropriate record keeping in relation to student's attainment and learning.
- To work in conjunction with the Teaching and Learning Leadership Team to ensure the
 provision of high quality teaching and learning opportunities, to meet statutory
 requirements, the individual special educational needs and aspirations of the students.
- To encourage, enable and promote effective communication with students, staff, parents and other departments in order to secure efficiency and high standards of achievement for students.
- To be aware of and pro-actively observe all school policies.
- To undertake all professional duties as set out in the 'School Teachers' Pay and Conditions Document' and, where applicable, relevant 'Performance Threshold Standards'
- To ensure that communication with students, staff, and other departments is effective and contributes to securing efficiency and high standards of care and personal development for students within a learning and residential environment.
- To maintain high standards of safety and observe good practice in relation to health and safety and safeguarding in all issues and report any concerns to line management.

- To pro-actively observe and comply with all school policies and procedures relating to child protection, equality and diversity, health, safety and security, confidentiality and data protection reporting all concerns to an appropriate person.
- To carry out tasks in order to ensure that the school runs effectively.
- To appropriately use the recording and reporting processes whenever appropriate.
- To maintain a flexible "can do" approach.
