Dear Colleague

Thank you for your interest in our school. We will have a vacancy for the post of Head of Economics and Business Education for September 2020 and having read the details of the post we hope you will wish to apply.

Bournemouth School for Girls is a selective girls' grammar school with over 1100 pupils, including 300 in the Sixth Form. At our most recent OFSTED inspection we were identified as 'outstanding'. In the latest Sunday Times Parent Power survey our school is rated 78th in the country. We are also a forward looking school – we are a member of the South West Academic Trust, a group of grammar schools in the region working together with Exeter University.

As well as Economics being an important subject area at A level, enterprise education plays an important part in the lower part of the school in helping to develop confident and well rounded, enterprise literate young people able to make a difference in the wider world when they leave school. For example in year 9 all pupils take part in an enterprise competition in which they develop, produce and sell products and then reflect on their experiences.

Other activities such as business breakfasts, practice interviews with local employers and enterprise projects all contribute to ensuring that our pupils have an experience that helps them understand the world of work.

We work closely with Young Enterprise and The Enterprise and Skills Company.

All pupils in year 10 complete a fortnight's work experience and all sixth formers also have the opportunity to complete placements.

### **The Post**

This is a full-time post and the successful applicant will be expected to lead and teach Economics at A Level. The ability to teach another subject such as maths will be an advantage.

You will also lead the wider enterprise education programme in the lower school, liaising with outside providers, our careers advisor and PSHE coordinator.

### **Economics at A level**

We currently offer two courses:

AQA Economics  
EDEXCEL Economics B

The department is well resourced with online subscriptions, laptops and exemplar materials.

- ❖ outstanding communication skills, both orally and written;
- ❖ well organised and totally reliable;
- ❖ good knowledge of current issues relating to Teaching and Learning;
- ❖ ability to work under pressure;
- ❖ loyalty and commitment to the team;
- ❖ flexible in approach and able to see the big picture;
- ❖ enthusiastic and able to bring new ideas to the school and department;

The post will attract a TLR2.2 responsibility allowance of £4,656.
