Main Scale Teacher

All teachers are subject to the Conditions of Employment set out annually in the School Teachers' Pay and Conditions Document, which detail the professional and particular duties required of teachers. Chilton Trinity complies with these requirements in order to make reasonable demands of teachers. The following Job Description is based on the Professional Standards for Teachers.

Expectations of teachers are that they should, in the area of:

Professional Attributes

- Maintain an up to date knowledge and understanding of the professional duties of teachers
- Contribute to the development, implementation and evaluation of school policies and practice
- Hold positive values and attributes, especially high expectations of students
- Adopt high standards of professional behaviour
- Communicate effectively with students, parents/carers, and colleagues
- Recognise the contribution that colleagues, parents/carers can make to the development and well being of students
- Have a commitment to collaboration and cooperative working
- Evaluate their own performance and be committed to improving their practice, especially through coaching/mentoring

and, that they should, in the area of:

Professional Knowledge and Understanding

- Maintain an up to date knowledge and understanding of a range of teaching and learning and behaviour management strategies
- Have a secure subject knowledge, including cross curricular applications, statutory and non statutory guidance, and relevant initiatives
- Know the assessment requirements for the subjects they teach
- Know a range of approaches to assessment, including formative
- Know how to use data to evaluate teaching, the progress of students, and to provide feedback to students
- Know and follow the national and local policies concerning the safeguarding of children and young people
- Understand how students develop, and factors which can influence this
- Know how to make effective personalised provision for learners, including EAL and SEN students
- Understand and use appropriately the role of colleagues in the learning, development and well being of students

and that they should, in the area of:

Professional skills

- Plan and deliver challenging, well organised lessons which promote progression and lead to raised attainment
- Establish a purposeful and safe learning environment
- Manage learners' behaviour by establishing a clear and positive framework in line with school policy
- Plan opportunities for students to develop literacy/ numeracy/ ICT skills
- Make effective use of assessment approaches to set challenging learning objectives and monitor progress
- Provide feedback on students' attainment, progress and areas for development
- Support students to reflect on their learning, identifying progress and areas for improvement
- Plan, set and mark appropriate homework tasks, including those in out of school contexts
- Work as a team member, and with other colleagues, to share the development of best practice within the school

This Job Description will be complemented by an annual CPD programme, which will detail individuals' development needs, and the support targeted to enable continued professional development.
