Role Profile: Music Teacher

Purpose

To take a key role in the creative development of the Arts, Culture & Communication Faculty with a Music specialism including defining the Music purpose and scope as a subject in its own right, including developing Music qualification pathways, and leading on the use of Music to support delivery other areas of the curriculum and life of the school.

To contribute to the raising standards of student achievement at Undershaw through the teaching of Music from KS2 – KS4 including the delivery of creative qualifications pathways at KS4 at a high level.

To oversee the building up of the resourcing of technical equipment and setting up, managing and maintaining subject specialist equipment, facilities, resources and spaces.

Maintaining risk assessments and H&S standards, managing a budget and ensuring that all lessons, workshops and visiting practitioners are in line with the school's H&S and safeguarding policies and protocols and that all checks are carried out in advance.

Managing the peripatetic teachers, timetable and offer.

Developing, directing and producing a programme of workshops, multi-media productions, exhibitions and showcases collaboratively with other subjects to deliver a programme of creative and artistic productions (including running rehearsals outside of standard school hours), exhibitions and events.

Delivering relevant CPD and cross-curricular planning and workshops with colleagues and quality assuring cross-curricular delivery and projects.

To research and report on the optimisation and potential for the delivery of and involvement in Music for those with SEND, including participating in research projects at school, local or national level.

To take on the role of a Form Tutor.

- To use assessment information, both externally and internally produced, to assess student performance and to develop appropriate courses of action; amending teaching as a result
- To maintain a level of personal development to ensure that subject knowledge and teaching methods continue to be enhanced.
- To work as a member of a team, positively contributing to effective working relations and deployment of staff within the school
