Context statement

Katherine High School is the only government secondary school in Katherine. It provides an educational service to students from Year 7 to Year 12. The school caters to a diverse population from a range of social, educational and cultural backgrounds. Our Pathways program supports students with previous low attendance and who are from small communities to transition into mainstream education. In 2021, Pathways will be partnering with the Northern Territory School of Distance Education (NTSDE), using the co-teaching model to deliver English and Mathematics through the HEAL program.

Key duties and responsibilities

- **1.** Work collaboratively with NTSDE, using the co-teaching model, to provide high quality education in English and Mathematics through the HEAL program.

- 4. Demonstrated ability to implement positive behaviour strategies to support students identified as at-risk.
