## Child and young person development

- Support the learning process under the direction of the teacher or other appropriate staff.
- Provide, with appropriate guidance and supervision limits, educational, emotional and physical support to students.
- Provide intimate care to individual students as required.
- Assist in the implementation of appropriate behaviour management strategies as per schools behaviour policy.
- Observe a child or young person's behaviour, understand its context, and notice any unexpected changes.
- Know how to interact with children in ways that support the development of their ability to think and learn.
