



**Post:** Evening Cleaner

**Reporting to:** Cleaning Supervisor / Site Manager

### Role Purpose:

- Carry out the cleaning of the interior of the Academies to an agreed standard under the direction of the Cleaning Supervisor
- Ensure the highest standards of cleanliness and general hygiene are maintained within the Academies

### Role Tasks:

- The routine and non-routine cleaning of the Academies as directed by the Cleaning Supervisor
- Tasks will include sweeping, mopping, dusting, vacuuming, buffing floors, cleaning toilets, emptying bins and any ad hoc duties as required
- Clean hard surfaces, floor surfaces, walls, windows, fixtures, fittings and equipment using powered equipment as required
- Be aware of Health and Safety issues around the site
- Report breakdown of any equipment or perceived hazards/incidents in the workplace to the Cleaning Supervisor
- Ensure appropriate stock is replenished as required (e.g. toilet roll)
- Complete any appropriate records or documentation required by the Academies
- Maintain good working relationships with other staff and co-operate with reasonable changes to daily work routines to assist with the smooth operation of the Academies
- To assist caretakers with ad hoc duties as required.

### Safeguarding

- Undertake regular safeguarding training as required
- Ensure that statutory and Ofsted requirements for Safeguarding are met
- To promote the safeguarding of young people

### General Responsibilities

- Contribute to the overall ethos / work aims of the academies
- Provide a courteous reception to staff, young people and visitors
