We seek to appoint a Casual Level 2 Swimming Teacher to join our fantastic team. Tewkesbury School Sports Centre Swim School provides swimmers the opportunity to develop from beginners through to an advanced level.

We are looking for a Swim Teacher to join our team on a casual basis to assist with its delivery of our Swim School lessons. We also run School Swimming lessons and may have some hours available to cover these (run during school hours and term time only).

Currently, our Swim School programme services over 250 children (with a waiting list of over 60 children) and runs for 50 weeks of the year (2 weeks off over the Christmas period) and presently takes place every weekday afternoon from 3.30pm and Saturday mornings from 9am. There are a variety of hours available.

Additional hours will be available for cover, plus School Swimming lessons, as well as having the opportunity to coach 121 Swim Lessons.

Our qualified instructors help all individuals achieve their goals as well as gain confidence in the water. Swimming lessons follow the Swim England Learn to Swim Framework starting at Stage 1 through to Stage 7.

Tewkesbury School Sports Centre is based in the grounds of Tewkesbury School. It is a Dual Use centre, which means that the school students use the facilities during school hours and the wider community can use the facilities in the evenings, weekends and school holidays.

# Job Description Swimming Teacher

Job Title: ASA Level 2 Swimming Instructor

Grade: Competitive hourly rate on a casual claim basis

**Purpose of Job:** To assist with the provision of a high level of instruction and coaching to customers attending the Sports Centre's swimming coaching programme

**Working Pattern:** Hours to be dependent on Sports Centre needs and availability, worked on a rota basis including weekend and evenings. Flexibility is required to cover the full range of shifts.

#### **Main Duties and Responsibilities:**

The normal duties of the post holder will usually include the following:

- a.) To teach swimming to children from age 4 years old upwards in line with the ASA National Teaching Plan.
- b.) To teach swimming to adults as required
- c.) To assist with the grading and examination of participants in accordance with the guidelines of the governing body. Report the outcome of any examination to participants in a professional manner
- d.) To ensure that all lesson plans and registers are kept up to date.
- e.) To assist the Estates Team in the development of the programme.
- f.) To ensure that the service and facilities are presented in such a way as to give customers the opportunity to have a safe and enjoyable leisure and/or learning experience
- g.) To welcome all users of the facilities promoting a positive image of the facility and School by the provision of high quality customer service.
- h.) To deal with customer comments and questions in a positive manner, ensuring that all feedback is recorded on the appropriate forms and forwarded for action accordingly
- i.) To wear any uniform that the School request.
- j.) To comply with the Emergency Action Plan for the facilities and assist with any such incidents in the appropriate manner.
- k.) To maintain such qualifications as may be required by the School, attend staff training sessions as required and maintain an appropriate level of physical fitness to carry out all duties
