We are a Church of England academy in the beautiful historic City of York and our Christian values guide influence and underpin all that we do. We are an outstanding academy with a reputation for academic excellence. In 2020, 80% of our students achieved grades 9-4 in English language or literature and maths, 60% achieved grades 9-5 in English language or literature and maths, these results are very high and well above national averages. 53% achieved the English Baccalaureate at grade 4 and above.

In recent years, we have taken on the role of a National Support School and our Teaching School is at the heart of the EborHope Teaching Schools Alliance, training the next generation of teachers. Subject Leader of Computer Science and ICT,

Including development of school-wide 1:1 technology (TLR 2)

Manor CE Academy is a church school that strives to hold the Christian faith at the heart of all it does. Its aims of **serving others, growing together and living life to the full** reflect the teachings of Jesus. The values at the heart of the school are for every staff and student to be **gracious, compassionate, loyal, patient, kind, forgiving and just.**

Outline of the Role:

This role is responsible for high quality teaching of Computer Science and ICT at Key Stages 3 and 4, involving the development of school-wide 1:1 technology. You will have a passion for working with young people, ensuring that all students enjoy, make outstanding progress and develop a love of learning in Computer Science and ICT, and iPad technology. You will also be:

- able to work collaboratively with the department and wider school staff
- committed to raising standards of learning for all
- focused on improving teaching and learning
- a creative and innovative thinker
- a team player with excellent interpersonal and communication skills
- keen to engage in their own continuous professional development

Leadership Responsibilities

The Teacher of Computer Science and ICT and development of 1:1 technology (TLR 2) as part of their role will:

- Lead on teaching and learning in Computer Science and ICT. Support vocational ICT.
- Lead on the development of school wide 1:1 technology in relation to teaching and learning
- In collaboration with the Director of Learning: DT, Art & Computing, lead on the curriculum design, planning and schemes of work in relation to Computer Science and ICT (this will include working with the academy leadership team in choosing the most appropriate examinations)
- Lead on the use of educational resources including capitation in Computer Science and ICT and the development of 1:1 technology
- Assist in the training of current staff and any colleagues undertaking teacher training in relation to Computer Science and ICT and the development of 1:1 technology
- Other reasonable duties as required by the Principal

The Computer Science and ICT Department

We are a dedicated, creative and highly successful team across the faculty and looking to appoint a sole Computer Science and ICT specialist; our summer 2020 results saw 76.2% of our cohort entry achieve Grade 4 (basic pass) or higher. Across the school, students have 12-16 hours per year of Computer Science at KS3 and 3hrs per week at KS4. In non COVID times, the Computer Science department occupies 1 full sized computer suite. It is equipped with a class set of student PCs, lead PC with dual-screens, Apple TV and a projector. There are also 2 members support staff for ICT and the 1:1 Technology project, an ICT prep room, an ICT office and you will share a workroom with the Art and DT staff. The workroom becomes a place for the team to congregate during breaks, fostering an extremely supportive and friendly atmosphere.

At Key Stage 3, all students follow a varied rotational curriculum, balancing different skills and subject disciplines across DT, Art and Computing. The majority of our Computer Science teaching at KS3 covers Digital Literacy & online e-safety, coding, history of computing, software & components, website creation and programming.

Year 10 and 11 are our GCSE years, in which skills for the Key Stage 4 curriculum are covered and consolidated. All students currently study the AQA Computer Science GCSE course (8525).

Main Teaching Duties

1. Set high expectations which inspire, motivate and challenge learners and students

- Establish a safe and stimulating environment for pupils, rooted in mutual respect
- Set goals that stretch and challenge pupils of all backgrounds, abilities and dispositions
- Demonstrate consistently the positive attitudes, values and behavior, which are expected of pupils.

2. Promote good progress and outcomes by learners and students

- Be accountable for pupils' attainment, progress and outcomes
- Be aware of pupils' capabilities and their prior knowledge, and plan teaching to build on these
- Guide pupils to reflect on the progress they have made and their emerging needs
- Demonstrate knowledge and understanding of how pupils learn and how this impacts on teaching
- Encourage pupils to take a responsible and conscientious attitude to their own work and study

3. Demonstrate good subject and curriculum knowledge

- Have a secure knowledge of the relevant subject(s) and curriculum areas, foster and maintain pupils' interest in the subject, and address misunderstandings
- Demonstrate a critical understanding of developments in the subject and curriculum areas, and promote the value of scholarship
- Demonstrate an understanding of and take responsibility for promoting high standards of literacy, articulacy and the correct use of standard English, whatever the teacher's specialist subject

4. Plan and teach well-structured lessons

- Impart knowledge and develop understanding through effective use of lesson time
- Promote a love of learning and children's intellectual curiosity
- Set homework and plan other out-of-class activities to consolidate and extend the knowledge and understanding pupils have acquired
- Reflect systematically on the effectiveness of lessons and approaches to teaching
- Contribute to the design and provision of an engaging curriculum within the relevant subject area(s).

5. Adapt teaching to respond to the strengths and needs of all learners and students

- Know when and how to differentiate appropriately, using approaches which enable pupils to be taught effectively
- Have a secure understanding of how a range of factors can inhibit pupils' ability to learn, and how best to overcome these
- Demonstrate an awareness of the physical, social and intellectual development of children, and know how to adapt teaching to support pupils' education at different stages of development
- Have a clear understanding of the needs of all pupils, including those with special educational needs; those of high ability; those with English as an additional language; those with disabilities; and be able to use and evaluate distinctive teaching approaches to engage and support them.

6. Make accurate and productive use of assessment

- Know and understand how to assess the relevant subject and curriculum areas, including statutory assessment requirements
- Make use of formative and summative assessment to secure pupils' progress
- Use relevant data to monitor progress, set targets, and plan subsequent lessons
- Give pupils regular feedback, both orally and through accurate marking, and encourage pupils to respond to the feedback

7. Manage behavior effectively to ensure a good and safe learning environment

- Have clear rules and routines for behaviour in classrooms, and take responsibility for promoting good and courteous behaviour both in classrooms and around the school, in accordance with the school's behaviour policy
- Have high expectations of behaviour, and establish a framework for discipline with a range of strategies, using praise, sanctions and rewards consistently and fairly
- Manage classes effectively, using approaches which are appropriate to pupils' needs in order to involve and motivate them
- Maintain good relationships with pupils, exercise appropriate authority, and act decisively when necessary.

8. Fulfil wider professional responsibilities

- Make a positive contribution to the wider life and ethos of the school
- Develop effective professional relationships with colleagues, knowing how and when to draw on advice and specialist support
- Deploy support staff effectively
- Take responsibility for improving teaching through appropriate professional development, responding to advice and feedback from colleagues
- Communicate effectively with parents with regard to pupils' achievements and well-being

As a teacher's career progresses, they are expected to extend the depth and breadth of knowledge, skill and understanding as is judged to be appropriate to the role they are fulfilling and the context within which they work.

PART TWO: PERSONAL AND PROFESSIONAL CONDUCT

A teacher is expected to demonstrate consistently high standards of personal and professional conduct. The following statements define the behaviour and attitudes which set the required standard for conduct throughout a teacher's career.

- Teachers uphold public trust in the profession and maintain high standards of ethics and behavior within and outside school, by:
- Treating learners and students with dignity, building relationships rooted in mutual respect, and at all times Observing proper boundaries appropriate to a teacher's professional position
- Having regard for the need to safeguard learners and students' well-being, in accordance with statutory provisions
- Showing tolerance of and respect for the rights of others
- Not undermining fundamental British values, including democracy, the rule of law, individual liberty and mutual respect, and tolerance of those with different faiths and beliefs
- Ensuring that personal beliefs are not expressed in ways which exploit learners and students' vulnerability or might lead them to break the law.
- Teachers must have proper and professional regard for the ethos, policies and practices of the school in which they teach and maintain high standards in their own attendance and punctuality.
- Teachers must have an understanding of, and always act within, the statutory frameworks which set out their professional duties and responsibilities.
