### THE ROLE

This is an exciting new post that will focus on empowering staff and students across the Trust to make best use of existing and emerging technologies to enhance teaching, learning and administration. The role involves playing a pivotal part in the development and implementation of a forward-thinking EdTech and AI strategy.

The post holder will help to create an environment of digital proficiency and innovation, ensuring that all members of the Trust are equipped with the skills and tools necessary to harness the full potential of technology in education.

### **KEY RESPONSIBILITIES**

- Support the development and implementation of a comprehensive EdTech and AI strategy aligned with the Trust's vision and educational goals.
- Collaborate with senior leaders and IT staff to ensure technology effectively supports teaching, learning, and administration across the Trust.
- Consider the use of existing and new technology to support accessibility needs, workload, and wellbeing.
- Conduct data analysis and research to identify opportunities for further innovation and resource optimisation.
- Stay informed about emerging EdTech trends and best practices, promoting knowledge sharing within the Trust

- Work with Trust's Learning and Development Manager, and school CPD Leads to design and deliver professional development programs to enable effective use of technology.
- Utilise relevant Trust wide groups such as Academic Communities to facilitate collaboration and sharing of EdTech innovation and best practice.
- Monitor the impact and usage of EdTech initiatives and platforms on student outcomes, teaching practices, and administrative efficiency.
- Collect and analyse data to assess the effectiveness of the Trust's EdTech strategy, making recommendations as needed.
- Create, develop, maintain, and quality assure technology training resources to ensure they are relevant, easy to access and follow by the relevant stakeholders.
- Be the lead for the Trust's Cloud based MIS, ensuring that schools are making best use of the system, and that staff are appropriately trained and supported.
- Visit schools to support their use of technology in the classroom, for example when implementing or trialling new technology initiatives.
- Run 1 to 1, group, and Trust wide technology training sessions delivered personally and/or with external trainers when needed.
- Use of the IT Service Desk to respond to training requests, identify training needed, and to help support the wider team during busy periods, or where staff are absent.
- Collaborate with external partners, such as vendors and educational organisations, to leverage expertise and resources.
- Be aware of and comply with policies and procedures relating to safeguarding, child protection, health and safety, security, confidentiality and data protection, reporting all concerns to the appropriate person.
- Undertake any duties, consistent with this position, which might, from time-to-time, be assigned by the Director of IT, or the Chief Executive.
