The role in a nutshell

Children with additional needs deserve to be treated the same as all other groups of children. They deserve to have the same opportunities and learn the things that their mainstream peers learn. Our specialist school is seeking a qualified teacher who cares about unique children, is keen to see them doing well, but who will push their limits to succeed.

The candidate

The ideal candidate will be:

- Passionate about complex children and committed to meeting their personal needs.
- Committed to school improvement and raising levels of pupil achievement
- A reflective practitioner, with the ability to plan strategically
- Someone who can demonstrate excellent organisational, communication and inter-personal skills with colleagues and parents/carers
- Will share and support the academy's ethos, and have energy and commitment to all aspects of academy life
- Focused on high expectations of learning and behaviour
- Committed to inclusion, and have a caring and adaptable approach in supporting children of all abilities
- A good team player and committed to the wider life of the academy
- A suitably qualified teacher, ideally with experience of special educational needs.

You will help children and young people learn and develop the skills and character required to foster confidence, curiosity, creativity and empathy. We believe they will progress with the spirit and character necessary to embrace life's challenges.

We welcome applications from everyone who believes they meet the expectations of the role regardless of age, gender, ethnicity, sexual orientation, faith, or disability.
