The SEND Learning Mentor will oversee students within our Student Support Room working closely with teachers to support the pastoral and academic work for students with SEND and medical needs. The Learning Mentor will also act as a Cover Supervisor.

The postholder will receive a payment in respect of their pro rata entitlement to Annual Leave appropriate to their grade, Bank Holidays and the KCC concessionary day which is included in the salary above.
