### Role Specification

- Ensure Dispensary is manned for dispensing stock and equipment.
- Ensure rooms/cupboards/trolleys are at a suitable standard for teaching and prepared for practical exams. Replenish materials and resources.
- Prepare daily stock for daily lessons and unpack returned from lessons including for outside demonstrators.

- Supervise laundry and ensure sufficient resources with assistance from students. Ensure laundry cycle is kept going throughout the day. General housekeeping of laundry room.
- Assist in all aspects of stock control - ordering all stock and equipment (subject to budget holder's approval) and stock and dealing with suppliers.
- Update inventory of furniture, towels and equipment and book and assist with annual servicing of electrical equipment.
- Organise maintenance/repair of furniture and equipment. Arrange for safe disposal of all broken down and non-repairable equipment. In accordance with WEE regulations. Complete disposal form.
- Compare and prepare costings and prepare Capital Bid submission annually.
- Check and update COSHH requirements/Risk Assessments for products and equipment.
- Clean all beds/workstations, stools and trolleys, machines and equipment with assistance from students throughout academic year and at the end of academic year.
- Prepare jobs to be completed and assess students on Dispensary duty daily – give verbal and written feedback at the end of the duty. Report to tutor's absences for the above.
- Provide help and assistance on hair and beauty reception as required.
- Assist tutors during lessons as required.
- Any other duties as required by curriculum manager.
