- Preparing and maintaining a variety of sports pitches and surfaces to the highest standard
- Preparation and upkeep of lawns and decorative areas, mowing, strimming, pruning and weeding
- Clean drives and pathways of debris, litter picking, clearing snow and keeping all site infrastructure to the highest standard
- Carry out a varied range of horticultural and grounds operations requiring minimum supervision and using own initiative, such as weeding, digging, edging, over seeding, soil preparation, pruning, tree maintenance and sports pitch preparation
- Safely use, maintain and clean all equipment after storage and ensuring secure storage
- Work in a tidy, safe and professional manner
- Follow departmental and school policies
- Undertake other duties that are required and are commensurate with the grade of post

 - Pesticides application PA1, PA2 and PA6
 - Chain saw CS30 and CS31
