## **Role Description**

#### Purpose

To assist the Examination and Assessment Manager by ensuring we provide optimal exam conditions for all students. You will be required to supervise examinations, such as GCSE, GCE and mock exams to ensure we uphold and safeguard the regulations and requirements of the relevant examining boards and protect the integrity of examinations.

The invigilator is the person in the examination room responsible for conducting a particular examination session in the presence of candidates.

#### Key Responsibilities

- Responsible for collecting papers from the Examinations Office.
- Responsible for starting, conducting and finishing examinations in accordance with the Joint Council for Qualifications instructions.
- Responsible for returning completed examination papers and all other stationery to the Examinations Office immediately after the examination.
- Supporting the Examination and Assessment Manager by following instructions and guidance.

The above duties are not exhaustive and the post holder may be required to undertake tasks, roles and responsibilities as may be reasonably assigned to them by the Principal.

## **Person Specification**

#### Experience

- Working with young people / working in a school setting is desirable but not essential.
- No specific exam invigilating experience is required as full training and ongoing support will be provided.

- The ability to both patrol the examination room on a regular basis and to stand for long periods of time. This is necessary in order to monitor the conduct of students.

- The aim of a core-knowledge education is not primarily to prepare pupils for a job or career, it is more to transform their minds so that they are able to make reasonable and astute judgments and engage fruitfully in conversation and debate not just about contemporary issues, but also about the universal questions that have been troubling mankind throughout history.
- We want children to leave our schools with the confidence that comes from possessing an essential general knowledge. A knowledge- rich education should not confine itself to the Western canon, but should embrace other cultures and traditions. What that canon includes will be subject to review, but will always be closely connected to the history and the present nature of the society in which we live, including our international connections.
