Job Description

Job Purpose

- a) To carry out the professional duties of a teacher in accordance with the school's policies and procedures in order to provide high quality teaching and learning, and improved standards of learning and achievement for all students.

Role and Responsibilities

Lesson Planning, Teaching and Learning

- Planning for outstanding teaching and learning, in line with the schools Teaching and Learning Policy / Employee Review Handbook, **through:**
 - Creating a climate for learning that is conducive for outstanding practice;

- Identifying and communicating clear learning objectives;
 - Identifying SEN (POD), EAL and G&T students and ensuring that their needs are met through differentiation / personalised learning;
 - Providing clear structure and planning for lessons and learning activities that maintain pace, challenge and engagement;
 - Making effective use of assessment for learning;
 - Making effective use of performance data and key indicators to inform planning and therefore deliver differentiated lessons;
 - Making effective use of ICT to enhance learning and progress.
- Maintaining discipline in accordance with the school's 'Behaviour for Learning Policy' and encouraging good practice with regard to punctuality, behaviour, uniform, standards of work and homework;

Assessment, recording, reporting

- Assess how well learning objectives have been achieved and use them to improve specific aspects of teaching and learning;
- Mark students work regularly, and set targets for progress, in accordance with the school's Marking & Feedback Policy;
- Assess and record students' progress systematically and keep records; using performance data to inform planning, student learning and progress;
- Prepare and present informative reports to parents in line with Report Writing Guidelines;
- Attend and support parent / student events.

- Take part in IB / subject development by producing, reviewing and updating innovative and engaging curriculum plans and units of work;
- Keep subject knowledge up-to-date through PD and professional reading

Other duties and responsibilities

- Contribute to the school's ASA Programme by leading / supporting one after-school activity for at least one term (ASA excludes any IB revision / booster sessions);
- To be a DP Extended Essay Supervisor (Upper School);
- Undertake duties as part of the staff duty rota and Club House (Lower School);

- Cover for absent colleagues;
- Invigilate examinations, as required, to support the Examinations Officer and Summer MYP & DP Examination Schedule (Upper School);
- Support school events and activities.
- Collaborate with other Dwight Schools and colleagues within our global network.
- Any other duties as assigned by the Head of School.

Person Specification

The ideal candidate will share our mission and vision and be a skilled and experienced teacher the preferable teaching 2 subjects within MYP and DP. Relevant skills and experience will be required for any leadership vacancy in the school.

The successful candidate will have a university degree and teaching qualification from a recognised academic institution; a strong record of professional development; and a positive, solution-focused, flexible approach to work.
