Purpose

To direct learning and oversee the constituent subjects in the Discover faculty. To promote outstanding teaching, learning and feedback and, in so doing, achieve outstanding progress for all groups of students.

Responsible to the Headteacher and the Senior Leadership Team. Responsible for Faculty Teaching Staff.

The Learning Leader of Discover is directly responsible to the Headteacher through their SLT line manager for:

- Promoting outstanding learning and teaching within the Discover subject areas, sharing best practice and ensuring the subject staff promote interest and enjoyment in their subject areas;
- Ensuring effective teaching and assessment throughout the Discover subject areas and in a manner consistent with whole school policies;
- Monitoring and evaluation of teaching, pupil attainment and progress within the DISCOVER subject areas;
- Working closely with the link member of the SLT with an emphasis on improving the quality of teaching and raising achievement, wherever possible;
- Maintaining morale coupled with a shared commitment to improving standards wherever possible.
- Collaborating with the SLT and other Discover subject areas heads in helping to formulate, disseminate, and implement whole school policies and initiatives;
- Coordinating the work of constituent subject areas within the Discover subject areas so that there is a shared understanding of whole school policies and procedures and ensure that they are properly implemented, providing support where necessary:
- Holding regular Discover group meetings as part of a planned sequence of meetings in the year;
- Being well informed of pupil attainment and progress within the Discover subject areas and coordinating intervention where necessary;
- Overseeing the monitoring and evaluation of teaching, learning and assessment across the Discover subject areas, ensuring that subject staff interventions are timely and appropriate;
- Holding Discover subject staff to account, ensuring that there is consistency in approach and that school policies and procedures related to T&L, assessment and achievement and progress are followed;
- Liaising with the Discover subject staff with subject responsibility to ensure that they are following a consistent approach to self-reviews in their subject area and have a departmental improvement plan in place which closely follows the priorities of the SIP;
- Appraising members of the faculty;;
- To carry out such other duties relevant to the Discover subject areas that may be required from time to time.

Personnel Management

- Undertake staff appraisals as required;
- To provide related professional guidance to colleagues with the aim of securing high quality teaching and support for pupils with additional needs;

- To identify training and development needs of staff and support development within the financial parameters imposed by the budget;
- Participate in the recruitment personnel and ensure effective induction of new staff in line with school procedures;
- Participate in the school's Initial Teacher Training programme as required;
- To collaborate with Heads of Departments and pastoral staff to ensure that all students have equal access to learning;

Teaching and Learning

- To develop, with the support of the Head, SLT and other colleagues, effective ways of overcoming barriers to learning;
- To ensure an effective learning environment and support other staff in the implementation of positive behavior management;
- To proactively liaise with other relevant institutions in planning referrals and reintegration programmes;
- To contribute to the in-service training of staff in the good practice of SEND teaching and support.

Knowledge and Skills

- Keep up to date with national developments regarding teaching practice/methodology and leadership initiatives;
- Keep up to date with developments in the use of comparative data;
- Demonstrate a high degree of emotional intelligence and empathy;
- Promote and maintain effective and professional communication with individuals and groups.

Quality Assurance

- Establish and reinforce common standards of good practice;
- Monitor and evaluate performances against school, local and national performance indicators;
- Monitor the quality of teaching and learning and support in line with the requirements of self-evaluation and the School Improvement Plan.

Meetings

- Meet regularly, as required, with the SLT and attend Governor/SLT meetings on request;
- Chair and facilitate departmental meetings;
- Attend relevant meetings including review and multi-agency meetings and Local Hub network meetings.

Additional Information

- Undertake any such duties commensurate with the post as directed by the Head teacher/Line Manager
