A detailed action plan has been developed for each of our school / Local Authority priorities. Some of the tasks included within these plans are listed below.

Priority 1:-Teaching & Learning

1. Differentiation

Provide appropriate differentiated materials for all pupils. Provide Teaching Resources on Office 365 Provide Autism training for whole staff

2. Pupil Voice

Develop Pupil Voice so that all pupils have an opportunity to feedback on each class at least once per year. Respond to results of pupil H&WB evaluation around SHANARRI indicators
Continue to develop and respond to pupil council and whole school pupil surveys

3. Employability skills

Identify employability skills being delivered in curriculum and highlight to pupils in class and via year group assemblies

Hold a whole school careers fair for all year groups

Priority 2 :- Raising attainment for all with a special focus on care experienced pupils and those living in poverty

4. Tracking and Monitoring

Continue to use and develop EDICT tracking and monitoring to support quality Learning conversations.

Better use of our cause for concern system

Have more effective interventions to improve progress and behaviour

5. Moderation & assessment

Ensure high quality moderation of assessment tools within and across subjects in the BGE and Senior Phase to ensure consistent standards within and across subjects.

6. Closing the attainment gap

Track and analyse department attainment and achievement with a focus on SIMD data to ensure appropriate targeted interventions in order to maximise pupil achievement.

Priority 3:- Additional School Priorities

Commissioning of an extension to the new school with proposed completion summer 2021

Develop our professional learning community through Professional Enquiry, and further leadership training for staff.

Increase our international links with Hong Kong and open new links with schools in mainland China to support our teaching of Chinese language.

- Continued focus on increasing whole school registration with MWOW from current 56% of cohort
- Introduced new Careers Rota for all S5 pupils with a focus on implementing the career standards
