Curriculum Provision:	To assist the Head of Faculty to ensure that the curriculum area provides a range of teaching which complements the school's strategic objectives.
Curriculum Development:	To assist in the process of curriculum development and change so as to ensure the continued relevance to the needs of pupils, examining and awarding bodies and the school's Mission and Strategic Objectives.
Staffing Staff Development:	To take part in the school's staff development programme by participating in arrangements for further training and professional development.

Pastoral System:	<ul> <li>To evaluate and monitor the progress of pupils and keep up-to-date student records as may be required.</li> <li>To contribute to the preparation of action plans and progress files and other reports.</li> <li>To alert the appropriate staff to problems experienced by pupils and to make recommendations as to how these may be resolved.</li> <li>To communicate as appropriate, with the parents of pupils and with persons or bodies outside the school concerned with the welfare of individual pupils, after consultation with the appropriate staff</li> <li>To apply the behaviour management systems so that effective learning can take place.</li> </ul>
Teaching:	<ul> <li>To plan and deliver engaging lessons that will motivate all pupils to improve their language skills.</li> <li>To teach, pupils according to their educational needs, including the setting and marking of work to be carried out by the student in school and elsewhere.</li> <li>To assess record and report on the attendance, progress, development and attainment of pupils and to keep such records as are required.</li> </ul>

- To provide, or contribute to, oral and written assessments, reports and references relating to individual pupils and groups of pupils.
- To ensure that ICT, Literacy, Numeracy and school subject specialism(s) are reflected in the teaching/learning experience of pupils
- To undertake a designated programme of teaching.
- To ensure a high quality learning experience for pupils which meets internal and external quality standards.
- To prepare and update subject materials.
- To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus.
- To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
- To undertake assessment of pupils as requested by external examination bodies, departmental and school procedures.
- To mark, grade and give written/verbal and diagnostic feedback as required.

## Other Specific Duties:

- To play a full part in the life of the school community, to support its distinctive mission and ethos and to encourage staff and pupils to follow this example.
- To promote actively the school's/Trust's policies.
- To continue personal development as agreed.
- To comply with the school's Health and safety policy and undertake risk assessments as appropriate.
- Comply with the school's Safeguarding policy and procedures and staff code of conduct
- To undertake any other relevant duties not mentioned in the above.
